This letter is to explain, express my regrets and request leniency for being late with my UBR this year. I accept this as one of my responsibilities regardless of the circumstances but the circumstances are as follows.

My wife of ten years and I got a divorce last year and I moved into an apartment in December. I'm not sure if my UBR came in the mail before or after I moved but in setting up in the new place my re-organization in my office has been painfully slow. My UBR was misplaced in the shuffle and never made it to the outgoing stack and I simply overlooked it. I do my own office work as well as work in the field and it is difficult to get all of my duties done on time but I do try.

I regret this error because I have worked very hard over the years to stay afloat and to provide a service that my customers are happy with, meet my obligations and treat employees fairly. Profits are low and a \$400.00 penalty will be hard to overcome.
