**ARTICLE I - NAME**

The name of this corporation is NEWVAL, INC. and its principal place of business is 6598 North Military Trail, Riviera Beach, Florida 33404.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of conducting any and all lawful business within the State of Florida.

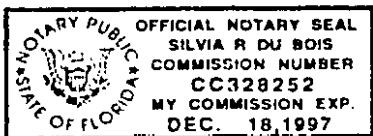
