ARTICLES OF INCORPORATION

ARTICLE I

ORGANIZATION

NAME:

This Corporation, formed under the Florida for profit S-corporation law, shall be known as FACES ENTERTAINMENT COMPLEX, INC. hereinafter referred to as "the Company".

OFFICES:
