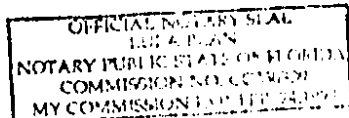

**ARTICLE III.** The corporation has not commenced business

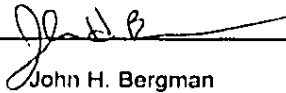
**ARTICLE IV.** No debts of the Corporation remains unpaid.
