## ARTICLE 1. - NAME AND ADDRESS

The name of this corporation is CLAUDE & WANDA'S BARBER & BEAUTY SHOP, INC., a Florida corporation, and the principal office is located at 2150 Tamiami Trail, Unit 20, Port Charlotte, Florida 33952.
