ARTICLES OF INCORPORATION
OF
DYTN CORPORATION

By these Articles of Incorporation the Incorporator forms a corporation for profit under Florida law.

FIRST: The name of the corporation is DYTN CORPORATION, INC.

SECOND: This corporation shall exist perpetually.

THIRD: The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

FOURTH: The maximum number of shares of stock that this corporation is authorized to issue is Five Hundred (500) shares of common stock with no par value, and additional shares of stock may not be authorized unless approved by the affirmative vote or written consent of the holders of at least two-thirds (2/3) of the outstanding shares of common stock.

FIFTH: The holders of the outstanding shares of stock of the corporation shall have preemptive rights in, or preemptive rights to purchase or subscribe to, any shares of the corporation, or any bonds, debentures or other securities convertible into any shares of the corporation.

SIXTH: The principal office address and mailing address of the corporation and the street address of the initial registered office of this corporation is 1217 Dockside Place, #105, Sarasota, Florida 34242. The name of the initial registered agent of this corporation at that address is Sarasota Consulting Services, Inc.

SEVENTH: This corporation shall have one (1) director initially. The number shall be fixed by the by-laws and may be changed from time to time.

EIGHTH: The names and street addresses of the initial director is:

The director shall hold office until the first annual meeting of shareholders.

NINTH: There may be no amendment, repeal or waiver of the application of any provision of these Articles of Incorporation, without the affirmative vote or written consent of the holders of at least two-thirds (2/3) of the outstanding shares of common stock.
