3. The corporation shall have the authority to issue 100 shares of common stock, in one class only, each with a par value of \$1.00.


4. The registered agent of the corporation is Paul Mitchell and the registered address is 319 Southeast 11th Avenue, Fort Lauderdale, Florida 33301.

6. The incorporator of this corporation is Paul Mitchell whose address is 319 Southeast 11th Avenue, Fort Lauderdale, Florida 33301.


