ARTICLE I

NAME

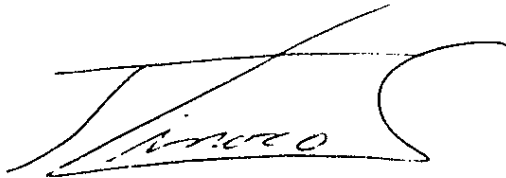

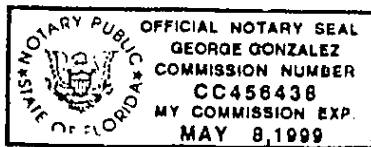
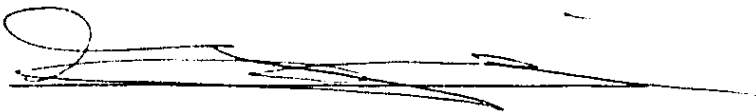
