# ARTICLES OF INCORPORATION

OF

GREATHOUSE BUTTERFLY PARM, INC. SECRETARY OF STATE TALL AHASSIE, FLORIDA

The undersigned subscriber(s) to these Articles of Incorporation, being natural person(s) competent to contract, hereby, for the purpose of forming a corporation under the laws of the State of Florida, adopt the following Articles of Incorporation for such corporation:

## ARTICLE I

NAME The name of the corporation shall be GREATHOUSE BUTTERFLY FARM, INC.

## ARTICLE II

NATURE OF BUSINESS The general nature of the business to be transacted by this corporation is:

- 1. To produce for wholesale and retail purposes butterflies, insects and assessories.
- 2. To conduct business in, having one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real property and personal property, including franchises, patents, copyrights, trademarks, and licenses in the State of Florida and all other states and countries.
- 3. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes, and other evidences of indebtedness, and execute such mortgages, or transfers of corporate indebtedness as required.
- 4. To purchase the corporate assets of any other corporation engaged in same or other character of business.
- 5. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge, or otherwise acquire or dispose of shares of the capital stock of, or any bond securities, or other evidence of indebtedness created by this or any other corporation of the State of Florida or any other state or government, and while owner of such stock exercise all rights, powers, and privileges of ownership, including the right to vote such stock.
- 6. To engage in any other lawful activity or business

  permitted under the laws of the State of Florida and of the United

States of America.

#### ARTICLE III

CAPITAL STOCK The maximum number of shares of stock this corporation is authorized to have outstanding at any time is 7,000 shares of common stock at a par value of One Dollar (\$1.00) per share.

#### ARTICLE IV

INITIAL CAPITAL The amount of capital with which this corporation will begin business is Five Hundred Dollars (\$500.00).

## ARTICLE V

TERM OF EXISTENCE The corporation is to exist perpetually.

# ARTICLE VI

ADDRESS The initial address of the principal offices of the corporation is Star Route Box 1120, Earlton, Florida 32631. The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

#### ARTICLE VII

DIRECTORS The corporation shall have four Directors initially. The number of Directors may be increased or decreased from time to time in accordance with the By-Laws adopted by the stockholders but shall never be less than one (1) or more than nine (9). Each Director shall be entitled to one vote on all issues voted on by the Board of Directors.

#### ARTICLE X

REGISTERED AGENT AND REGISTERED ADDRESS Zane Greathouse, whose address is 5812 NW 63 Court, Gainesville, Florida 32653-3211, is authorized to serve as the initial registered agent of the corporation to accept service of process as resident agent of the corporation.

## ARTICLE XI

PRE-EMPTIVE RIGHTS Each shareholder of this corporation shall have a pre-emptive right to purchase additional shares of the corporation at any such time as the same are offered for sale by the corporation.

#### ARTICLE XII


