The undersigned Incorporator subscribing to these Articles of Incorporation, being competent to contract, hereby forms a Corporation under the Laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be: SUNCOAST BRACE & LIMB, INC., and its initial mailing address shall be: 1878 59TH STREET WEST, BRADENTON, FL 34209. The initial address of the Corporation's principal office shall be: 1878 59TH STREET WEST, BRADENTON, FL 34209 .

ARTICLE II

ARTICLE VI

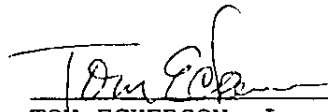

ARTICLE VII

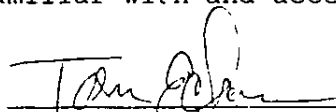
These Articles of Incorporation may be amended in the manner provided by law.
