ARTICLES OF INCORPORATION

OF

TRI-COUNTY HOME INSPECTIONS, INC.

The undersigned, acting as incorporators of a corporation under the Florida General Act, adopt the following articles of incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is Tri-County Home Inspections, Inc.

ARTICLE II. TERM OF EXISTENCE

The period of its duration is perpetual.

ARTICLE III. GENERAL NATURE OF BUSINESS

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV. CAPITAL STOCK

The corporation shall have authority to issue 100 shares, Common Stock, at \$1.00 par value.

ARTICLE V. INITIAL REGISTERED AGENT AND OFFICE

The address of the initial principal office is 7416 Lake Ola Drive, Tangerine, Florida 32777, and the name of the initial registered agent at said address is Harry A. Alvarez.

ARTICLE VI. MANAGEMENT BY SHAREHOLDERS

The business of this corporation shall be managed by its shareholders rather than by a Board of Directors. The shareholders reserve unto themselves the power to adopt, alter, amend, or repeal the by-laws of this corporation. In the management of the business of the corporation, the act of the shareholders representing a majority of the outstanding shares of the corporation entitled to vote, represented in person or by proxy, shall be the act of the shareholders. Each shareholder shall be entitled to one vote in person, or by proxy, for each share of voting stock held by him. A majority of the outstanding shares of the corporation entitled to vote, represented in person, or by proxy, shall constitute a quorum
