ARTICLES OF INCORPORATION OF ALDO INC. PORATIONS

95 SEP -5 AHIO: 55

BY THESE ARTICLES OF INCORPORATION the incorporators form a corporation for profit under Florida Law.

ARTICLE I

The name of this corporation shall be ALDO INC.

ARTICLE II

This corporation shall have the power and authority to carry on business for the purposes and objects hereinafter set forth, and to do and perform the same as completely and as fully as any natural person is authorized to do under the laws of the State of Florida; that is to say, that this corporation may have the authority:

(a) To develop, design, manufacture, distribute, sell and service products of any kind and description.

(b) To buy, acquire, own, hold, improve, lease, sell and distribute any and all forms of personal property of every type and nature.

(c) To own, acquire, buy, sell, lease, exchange and deal in lands and real estate; to erect buildings and improvements thereon, to borrow and loan money on real estate and other security, and in general to exercise and perform any and all other powers necessary, incident or convenient to the business aforesaid.

(d) To acquire or sell and otherwise dispose of any deal in stocks, bonds, mortgages, notes, commercial paper of corporations or individuals, to borrow money and to secure the same by notes, bonds, deeds of trust, mortgages, and other obligations and securities; to subscribe for, purchase, acquire, hold for investments, own, sell, dispose of, and make advances upon notes, mortgages, state, county and municipal bonds, stocks, bonds, securities and obligations of other corporations, firms and individuals; to exercise all the rights, powers, and privileges incident to ownership thereof; and to have and exercise all and such other and further powers as may be incidental to or necessary or convenient to the several businesses of said corporation, and all rights, powers and privileges granted to corporations for profit by the laws of the State of Florida. (e) To engage in the business of finance, financing and ancillary activities as it appertains to trade, commerce and industry.

(f) To loan money for any purpose on such terms, conditions and provisions, and under such circumstances, as its management may deem advantageous, expedient or advisable.

(g) To engage in the business of buying, selling and trading of businesses and properties, both real and personal, either to the account of the corporation or for and in behalf of others.

(h) To have and acquire such machinery, equipment and facilities, either by purchase or lease.

(i) To borrow money in the name of the corporation and encumber or hypothecate the assets as security therefore.

(j) To hypothecate the assets of the corporation and encumber or hypothecate corporate assets as security therefor.

(k) This corporation shall have the rights, powers and privileges of dealing in its own stock, bonds, debentures and otherwise, and evidences of indebtedness, and to freely exchange any or all of these, together with full rights, powers and privileges of buying and selling the same so long as all applicable rules, regulations and statutes are complied with.

(I) To engage in any activity or business personal under the laws of the United States and of the State of Florida.

ARTICLE III

This corporation shall be authorized to issue 100 shares of common stock. Said shares of common stock shall have a par value of \$1.00 per share.

ARTICLE IV

The amount of capital with which this corporation shall begin business shall be \$1,000.00.

The street address of the principal office of this corporation shall be located at 215 S. Gordon Road, Fort Lauderdale, Florida 33301. The name of its initial registered agent shall be Donna Artes, whose address will be 215 S. Gordon Road, Fort Lauderdale, Florida 33301.

ARTICLE VI

This corporation shall have one director initially. The number of directors may be altered from time to time by the by-laws adopted by the stockholders.

ARTICLES VII

In lieu of the above described procedure, an amendment may be made by a written instrument signed by all of the directors and stockholders of this corporation.
