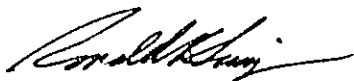

The undersigned incorporator(s), hereby make, subscribe, acknowledge and file with the Secretary of the State of Florida, these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

The name of this Corporation shall be Main House Antique Center, INC., 4980 38th Avenue North, St. Petersburg, Florida 33710-2140.

ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of engaging in any transaction or business activities, both domestically and abroad, for which corporations are permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

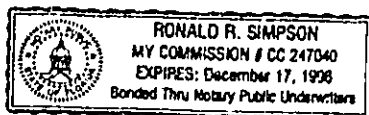
