The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of the corporation shall be: MAL, INC. The principal place of business of this corporation shall be 4607 E. Fern Street, Tampa, Florida 33610.

ARTICLE II NATURE OF BUSINESS

This corporation may engage in general building construction and allied services and transact in any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, country, territory, or nation.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 50,000 shares of common stock having a par value of \$1.00 per share. Total capital, \$50,000.

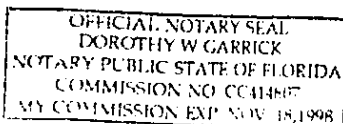
