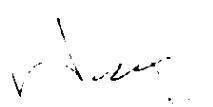

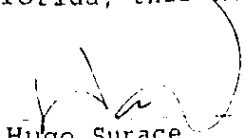
ARTICLE X-EFFECTIVE DATE

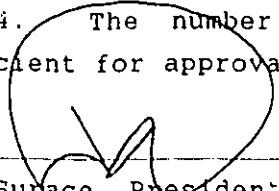

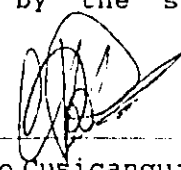
1. That affiants are the President/V. President/Treasurer/Director and stockholders of Override Communications, Inc., who has on the date set forth below resigned as officers.

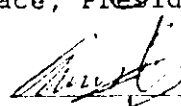
2. Be it amended that the the corporation officers is hereby changed and shall hereafter be known as Hugo Surace --President/ Vice President/ Treasurer/Director.
