ARTICLES OF INCORPORATION

OF

Hilliard Plumbing, Inc.

BY THESE ARTICLES OF INCORPORATION, the Incorporator forms a Corporation for profit under Florida law.

ARTICLE I - CORPORATE NAME

The name of this Corporation shall be Hilliard Plumbing, Inc., and the principal place of its business shall be, or such other place as the Board of Directors may from time to time designate.

ARTICLE II - DURATION OF EXISTENCE

This Corporation shall have perpetual existence unless sooner dissolved according to law. This Corporation shall begin business on the day of filing of these Articles of Incorporation.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any or all lawful business, including, but not limited to, the following:

(a) To do any and all acts and things, and to exercise any and all other powers conferred by the laws of Florida upon Corporations formed under the provisions of Chapter 607, Florida Statutes, 1989, as amended, and which now or hereafter may be authorized by law.

(b) To have and exercise all powers necessary or convenient to effect its purposes.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of stock outstanding at any time shall be 1,000, with a no par value of, all of one class, common, participating voting stock

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which such stock is offered to others.

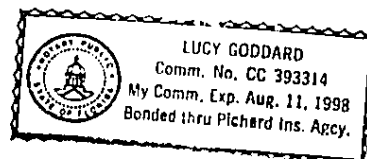
