ARTICLE 1 Name and Address

The name of this Corporation is: General Investment Enterprises, Inc. The mailing and street address of the Corporation is: 819 Bayahore Boulevard, Tampa, Florida 33606.

ARTICLE II Term of Existance

This Corporation shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.
