The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

ARTICLE I.-NAME

The name of the corporation is:

The general nature of the business to be transacted by this corporation shall be: IMPORT-EXPORT/RETAIL

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is: 100 SHARES AT \$1.00 PAR VALUE
