ARTICLES OF INCORPORATION OF TENNANT & TWARGOSKI, DMD'S, P.A. 95 ACS 31 TO 44 U.S.

The undersigned, being duly licensed to practice dentistry under the laws of the State of Florida, for the purpose of forming a professional service corporation under the Professional Service Corporation Act, Chapter 621, Florida Statutes, hereby adopt the following Articles of Incorporation

- 1 Corporate Name The name of the corporation is TENNANT & TWARGOSKI, DMD'S, P.A.
- 2. <u>Corporate Existence</u> The term of existence of the corporation shall be perpetual Corporate existence shall begin on August 28, 1995
- 3 Corporate Purpose The professional service corporation is formed to engage n the practice of dentistry. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of professional service
- 4. <u>Capital Stock</u> The total number of shares of stock which the corporation shall have authority to issue is 500 shares, all of which shall be common shares with a par value of \$1.00 per share
