OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida providing for the formation, rights, liabilities, privileges and immunities of a corporation for profit.

**ARTICLE I - NAME**

The name of the corporation shall be THERESA M. PETERSON, P.A.

**ARTICLE II - NATURE OF BUSINESS**

The purpose of this corporation is to engage in every aspect of the business of rendering the same professional services to the public that an Attorney at Law, duly licensed under the laws of the State of Florida, is authorized to render.

**ARTICLE III - GENERAL POWERS**

This corporation shall have and may exercise all powers now and hereafter conferred by the laws of the State of Florida.

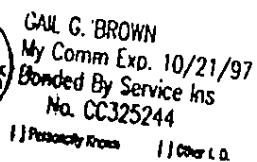
