2. The text of each amendment adopted is as follows:

4. The date the amendment reflected in these Articles of Amendment was adopted was November 7, 2012.

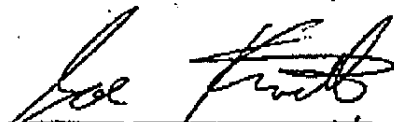
5. The amendment was approved by the directors and shareholders of the Corporation and the number of votes cast for the amendment by the directors and shareholders was sufficient for approval.
