ARTICLES OF INCORPORATION OF UNIMOTORCYCLE PRODUCTIONS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Pforidage Business Corporation Act, hereby adopts the following Articles of Incorporation

ARTICLE 1 - NAME

The name of this corporation shall be UNIMOTORCYCLE PRODUCTIONS, INC.
