3 30 7 5 ARTICLE 1: NAME

The name of this Corporation is FAT WAX, INC., constituted under chapter 607 Florida Statutes, identified and referred to as the Florida General Corporation Act.

#### ARTICLE 2: PURPOSE

#### ARTICLE 6: PRINCIPAL OFFICE

The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

## ARTICLE 9: BYLAWS

The initial Bylaws shall be adopted by the Board of Directors. The power to alter, amend or repeal the Bylaws, or adopt new Bylaws, is vested in the Board of Directors, subject to repeal or change by action of the shareholders.

## ARTICLE 10: INFORMAL SHAREHOLDER ACTION

## ARTICLE 12: QUALIFICATION OF DIRECTORS

The Directors of this Corporation must be a natural person, at least eighteen (18) years of age, but need not be a citizen of the United States, a resident of the State of Florida or a shareholder in the Corporation.

#### ARTICLE 13: REMOVAL OF DIRECTORS

A Director of this Corporation may be removed by the shareholders, of the Corporation, only for cause.

## ARTICLE 14: PREEMIT, IVE RIGHTS

Each holder of the come on stock, of this Corporation, shall have the first right (subject to adjustments to avoid the issuance of fractional shares) to purchase shares of any other securities that this Corporation may issue. From time to time, whether or not such shares are presently authorized, including shares from the treasury of this Corporation, in the ratio that the number of shares of common stock held by such shareholder, at the time of the issue, bears to the total number of shares of common stock then outstanding, exclusive of treasury shares. This right is waived by any holder of the common stock who does not exercise it and pay for the stock available for purchase, pursuant to such preemptive rights, within thirty (30) days of his receipt of a written notice, from this Corporation, stating the price, terms and conditions of the issue of shares and inviting him to exercise his preemptive rights.

## ARTICLE 15: AFFILIATED TRANSACTION RULES

The Affiliated Transaction Rules contained in Section 607.0901, Florida Statues shall not apply to this Corporation.

#### ARTICLE 16: AMENDMENT

This Corporation, through its Board of Directors, reserves the right to amend or repert any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right confelled aroun the shareholders is subject to this reservation.
