**ARTICLES OF INCORPORATION  
OF  
Active Electronic Supply and Manufacturing, Inc.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of this corporation is Active Electronic Supply and Manufacturing, Inc.

**ARTICLE II - PURPOSE**

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the State of Florida and the United States of America. This shall include, but not be limited to: manufacturing, research and development of telecommunication equipment, components, parts, supplies and materials; wholesale electronic components and all other related activities.

**ARTICLE III - CAPITAL STOCK**

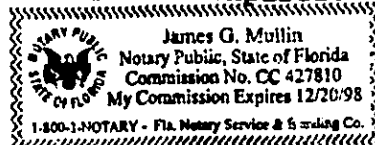


