The undersigned, for the purpose of creating a corporation under the laws of the State of Florida, does hereby adapt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be North American Telecommunications, Inc.

ARTICLE II - DURATION

The duration of the Corporation is perpetual, unless sooner dissolved by the officers or shareholders as provided for by the laws of Florida.

ARTICLE III - PRINCIPAL OFFICE

ARTICLE IV - PURPOSES AND POWERS

The purpose of the Corporation is to do any and all lawful business for which corporations may be incorporated under the laws of Florida
