ARTICLES OF INCORPORATION

OF

SEAJAYE REALTY, INC. of NEW SMYRNA BEACH

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is SEAJAYE REALTY, INC. of NEW SMYRNA BEACH.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing on the date of filing of Articles of Incorporation by the Department of State.

ARTICLE III. GENERAL PURPOSE
