The principal office and mailing address of the corporation will be: 4160 Ravenswood Road, Fort Lauderdale, Florida 33312.



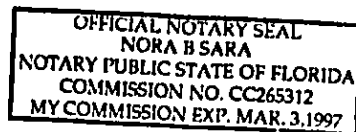
