ARTICLES OF INCORPORATION

OF

J. VICTOR CHANEY M.D., P.A.

THE UNDERSIGNED, ACTING AS INCORPORATOR UNDER AND BY VIRTUE OF THE LAWS OF THE STATE OF FLORIDA, AND PARTICULARLY THE FLORIDA BUSINESS CORPORATION ACT, AS PROVIDED IN CHAPTER 607, FLORIDA STATUTES, AND CHAPTER 621, FLORIDA STATUTES, AND ANY ACTS SUPPLEMENTARY THERETO, ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION FOR SUCH CORPORATION.

ARTICLE I NAME

THE NAME OF THIS CORPORATION SHALL BE:

ARTICLE II PRINCIPAL OFFICE

TO DO ALL AND EVERYTHING NECESSARY AND PROPER FOR THE ACCOMPLISHMENT OF ANY OF THE PURPOSES OR THE ATTAINING OF ANY OF THE OBJECTS OR THE FURTHERANCE OF ANY OF THE PURPOSES ENUMERATED IN THESE ARTICLES OF INCORPORATION OR ANY AMENDMENT THEREOF. NECESSARY OR INCIDENTAL TO THE PROTECTION AND BENEFIT OF THE CORPORATION, AND IN GENERAL, EITHER ALONE OR IN CARRY ON ANY LAWFUL PURSUIT NECESSARY OR INCIDENTAL TO THE OBJECTS OR THE FURTHERANCE OF SUCH PURPOSES OR OBJECTS OF THE CORPORATION.

ALL SUBSCRIPTIONS OF STOCK SHALL BE PAID FOR IN LAWFUL MONEY OF THE UNITED STATES OF AMERICA, OR IN PROPERTY, SECURITY, LABOR, SERVICES OR SUCH OTHER METHOD OF PAYMENT AS THE BOARD OF DIRECTORS MAY REASONABLY APPROVE, AT A JUST VALUATION BEING FIXED BY THE BOARD OF DIRECTORS AT A MEETING CALLED FOR SUCH PURPOSES; AND PROPERTY, LABOR OR SERVICES MAY ALSO BE PURCHASED OR PAID FOR WITH CAPITAL STOCK OF THE CORPORATION, AT A JUST VALUATION BEING FIXED BY THE BOARD OF DIRECTORS, AND THE CORPORATION MAY FROM TIME TO TIME INCREASE ITS CAPITAL STOCK TO ANY AMOUNT WITHIN AUTHORIZATION BY LAW.

ARTICLE V TERM OF THE EXISTENCE

THE TERM OF EXISTENCE OF THE CORPORATION SHALL BE PERPETUAL.
