ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation is IVY LANE NURSERY, INC.

ARTICLE II

This corporation shall have perpetual existence, commencing on the date of filing of these Articles with the Secretary of State of the State of Florida.

ARTICLE W

This corporation is organized for the following purposes:

- A. To engage in the operation of a plant nursery business;
- B. To transact any and all lawful business.
- C.
