The undersigned subscribers to these Articles of Incorporation, national persons competent to contract, hereby form a corporation under the laws of the State of Florida,

#### **ARTICLE I**

Name

The name of this corporation is DAVIS MARITIME, INC.

# ARTICLE II

Duration

This corporation shall exist perpetually.

### **ARTICLE III**

Corporate Purpose

This corporation is organized to transact any or all lawful business for which the corporation may be incorporated pursuant to Chapter 607, Florida Statutes, or any other applicable laws of the State of Florida.

## ARTICLE IV

Principal Office/Mailing Address
