ARTICLES OF INCORPORATION 95 SEP - 1 PH 2:01 OF SECRETARY OF STATE FLINT DRYWALL, INCORPORATED HASSEE, FLORIDA

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:
