ARTICLES OF INCORPORATION

OF

RIATA CORPORATION

The undersigned hereby form a corporation-for-profit under the Florida General Corporation Act by adopting the following Articles of Incorporation:

- 1. Name. The name of this corporation is Riata Corporation.
- 2. Nature, Purpose and Powers. This corporation shall have perpetual existence, commencing on the date that these Articles are filing. It will have the power to engage in any lawful business and have all powers enumerated in the Florida General Corporation Act.
- 3. <u>Capital Stock</u>. This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.
- 4. <u>Initial Registered Agent and Office</u>. The name and address of the initial registered agent of this corporation is: Marlow White at Lewis & White, L. C., 216 W. College Avenue, Suite 201, Tallahassee FL 32301.
- 5. <u>Initial Board of Directors</u>. This corporation shall have one director initially. The number of directors may be increased from time to time by the Bylaws but shall never be less than one. The name and the address of the initial director is: Robert Aaron Brown, 2453A Talco Hills Drive, Tallahassee FL 32303.
- 6. <u>Incorporator</u>. The name and the addresse of the person subscribing to these Articles of Incorporation is: Robert Aaron Brown, 2453A Talco Hills Drive, Tallahassee FL 32303.
- 7. <u>Director Conflict of Interest</u>. No contract or other transaction between this corporation and its director(s), or between this corporation and any other corporation, firm, association or other entity, in which one or more of its directors is a director or officer, or is financially interested

in the corporation, shall be either void or voidable for this reason alone or by reason alone that such director(s) consents to or is present at the meeting of the board of directors which approves such contract or transaction, or that his vote is counted for such purpose.

- 8. <u>Indemnification</u>. The corporation will indemnify any officer or director, or any former officer or director, pursuant to Section 607.014 of the Florida Statutes, as amended.
- 9. <u>Informal Action by Directors</u>. If the director (or all the directors if more than one) consent in writing to any action taken or to be taken by the corporation, and the writings evidencing his consent is filed in the corporation's minute book, the action shall be as valid as though it had been authorized at a formal meeting.
