ARTICLE 1 - NAME

The name of this corporation is DRC & ASSOCIATES, INC.. The mailing address of said corporation is 2151 Hillsboro Boulevard, Suite 110, Deerfield Beach, FL 33442.

ARTICLE 2 - DURATION

This corporation shall have perpetual existence. The effective date of this corporation shall be the date of filing.

ARTICLE 3 - PURPOSE
