ARTICLES OF INCORPORATION OF DENNIS L. YOUNGBLOOD, P.A.



The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I NAME

Section 1.1. Name. The name of the corporation is DENN'S L. YOUNGBLOOD, P.A.

Article II DURATION

Section 2.1. Duration. This corporation shall exist of perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are hot filed by the Department of State of Florida within ten days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

Article III PURPOSES
