Article I

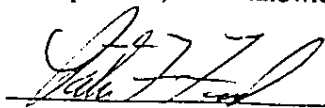

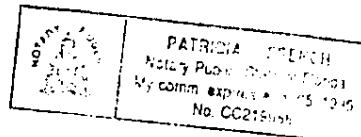
