## ARTICLES OF INCORPORATION

OF

## INSTANT AUTO LOANS INC.

ARTICLE I- NAME: The name of this corporation is INSTANT AUTO LOANS INC.

ARTICLE II- DURATION: This corporation shall have perpetual existence commencing on the <u>lst</u> day of <u>September</u>, 1995.


