ARTICLES OF INCORPORATION
OF
ROBERTS HOME IMPROVEMENTS, INC

We, the undersigned, hereby organize for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the said State of Florida, providing for the formation, rights, privileges, immunities and liabilities of corporations

ARTICLE I

The name of the corporation shall be Roberts Home Improvements, Inc.

ARTICLE II

The corporation may engage in the rendering of any lawful business.

ARTICLE III

The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be One Hundred (100) shares at Ten Dollars (\$1) par value each, which shares will be common stock.

ARTICLE IV

The amount of capital with which the corporation will begin business shall be \$1,000.00.

The corporation shall have perpetual existence.



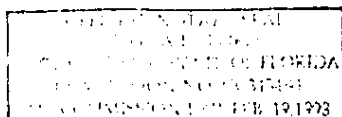


