NAME



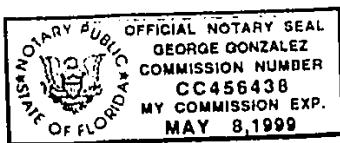


