# Articles of Incorporation of Select Sites of Biscayne, Inc. FLED 95 SEP - 5 PH 1: 57

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

### ARTICLE I - NAME

The name of this corporation is Select Sites of Biscayne, Inc.

### **ARTICLE II - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of Florida.

## ARTICLE III - CAPITAL STOCK

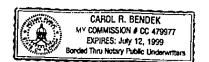
