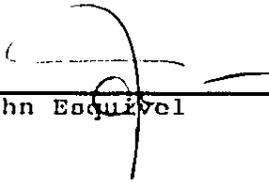

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, heroby adopts the following Article Of Incorporation.

ARTICLE I

The duration of the corporation shall be perpetual.

ARTICLE III

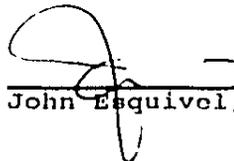

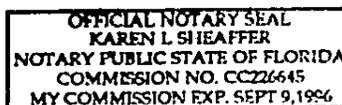

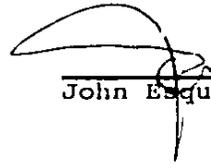
