ARTICLE OF INCORPORATION

OF

SUDAN ASSOCIATION, INC.

ARTICLE I

THE NAME OF THIS CORPORATION IS, SUDAN ASSOCIATION, INC. AND THE PRINCIPLE OFFICE AND MAILING ADDRESS IS: 15640 S.W. 58 ST. MIAMI, FLORIDA 33193.

ARTICLE II
