- (c) To engage in every aspect and phase of the business of selling, lawn and garden supplies, animal feeds, small tools, tires, garden equipment, generators, two and four cycle engines, inboard and outboard marine motors, riding mowers, push mowers, chain saws, blowers, pumps, line trimmers, hedge Trimmers, edgers, electric motors and for such items which are manually operated without motors, go carts and golf carts, both new and used, and all such services in connection therewith, on a retail basis.
- (d) To engage in every aspect and phase of the business of renting garden equipment, generators, two and four cycle engines, inboard and outboard marine motors, riding mowers, push mowers, chain saws, blowers, pumps, line trimmers, hedge trimmers, edgers, go carts and golf carts, electric motors and for such items which are manually operated without motors.
