ARTICLES OF INCORPORATION
OF

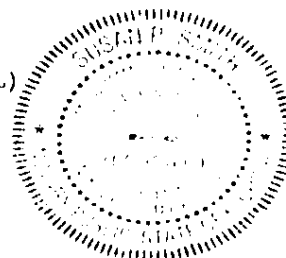




