ARTICLES OF INCORPORATION  
OF

BORELLI & GUILARTE INVESTMENTS, INC.

ARTICLE I-NAME

The name of this corporation is BORELLI & GUILARTE INVESTMENTS, INC.

ARTICLE II- DURATION

The Corporation shall have perpetual existence commencing on the date these Articles of Incorporation are filed with the Florida Secretary of State's Office.

ARTICLE III- PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV- CAPITAL STOCK

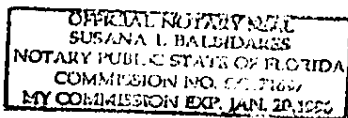
