ARTICLES OF INCORPORATION

I, the undersigned, Shirley P. Saffos, desire to become a body corporate and, as incorporator, do hereby make and file these Articles of Incorporation for a proposed corporation pursuant to the laws of Florida, and to that end hereby declare and affirm:

ARTICLE I

The name of this corporation shall be: MOONLIGHT LANE, INC.

ARTICLE II

This corporation shall exist perpetually unless sooner dissolved as authorized by law, and said corporation shall commence its existence at 6123 55th Terrace East, Bradenton, Florida 34203, August 29, 1995, or as soon thereafter as these Articles are filed with the Department of State of the State of Florida.

ARTICLE II

This corporation shall exist perpetually unless sooner dissolved as authorized by law, and said corporation shall commence its existence on the date of subscription and acknowledgment of these Articles, as hereinafter set forth, if these Articles are filed with the Department of State within five (5) days exclusive of legal holidays, after such date. If these Articles are not so filed, this corporation shall commence existence upon the filing hereof with the Department of State.


