

Article I - Name and Address

The name of this corporation is RSM HOLDINGS, INC. The address of this corporation is 301 South K Street, Lake Worth, Florida 33460.

Article II - Duration

This corporation shall have perpetual duration commencing on the date of execution and acknowledgment of these Articles.
