

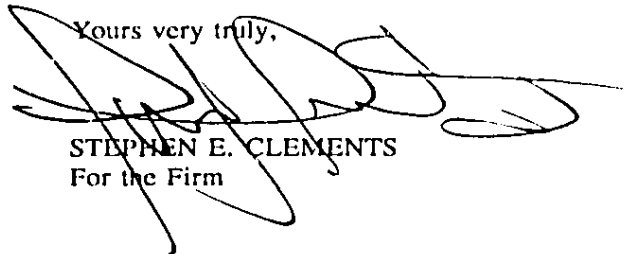

The undersigned, acting as incorporator of a corporation under the Code of Alabama, ^{FLA}ADOPTS adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Cox Nuclear Pharmacy-Tallahassee, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

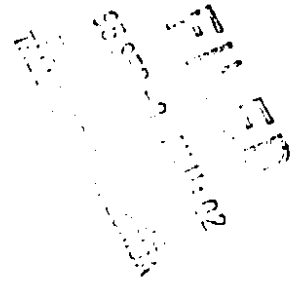

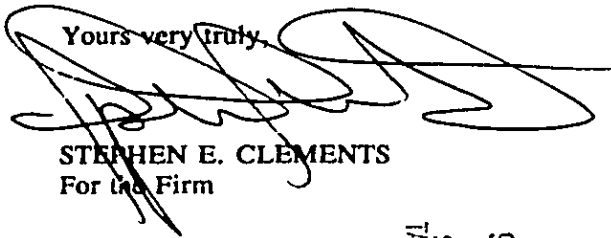
