ARTICLES OF INCORPORATION

OF

FUTURE COMMUNICATION CONSULTANTS, INC. 25 STD -5 11 Ct 29

The undersigned, for the purpose of forming a corporation under the Florida General Action Act, do hereby adopted the following Articles of Incorporation:

Article One - Name

The name of the corporation is FUTURE COMMUNICATION CONSULTANTS, INC.

Article Two - Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article Three - Term of Existence

The corporation shall have perpetual existence commencing upon the filing of these articles.

Article Four - Capital Stock

This corporation is authorized to issue a maximum of Five Hundred (500) shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares". The consideration to be paid for each share shall be fixed by the Board of Directors.

Section 1. Dividends:

Section 2. Rights upon Liquidation or Dissolution:

In the event of any voluntary or involuntary liquidation, dissolution or winding up of this corporation, after the payment of any and all debts and obligations, the remaining assets of this corporation shall be payable to and distributed ratably among the holders of record of the "Common Shares".

Section 3. Voting Rights:
