# ARTICLES OF INCORPORATION OF SPRING WATER MANAGEMENT I, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE
