Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to the Articles of Incorporation of Dorsey Construction Company, which were filed on September 6, 1995, and assigned document number P95000069453.

FIRST: The name of the corporation is Dorsey Construction Company.

SECOND: The following amendment to the Articles of Incorporation was properly adopted pursuant to Florida Statutes, Section 607.1006 by the directors and stockholders of the corporation eligible to vote, in the manner prescribed in the Florida Statutes:

Article III of the Articles of Incorporation providing for the shares of the corporation is hereby amended to read as follows:

**ARTICLE III - SHARES**

This corporation is authorized to issue 10,000 shares of \$1.00 par value common stock, all of one class and series.

THIRD: The date of the amendment's adoption: 11/18, 2003.

FOURTH: Adoption of Amendment.

The amendment was approved by 100% of the shareholders. The number of votes cast for the amendment was sufficient for approval.
